Notice of Public Meeting Committee of Adjustment

Application for Consent (Easement) has been submitted by Loft Planning Inc., on behalf of T.P.C Marlwood Avenue, owner of the subject lands.

Property Location: 31 Marlwood Avenue

Public Meeting Date: Wednesday, August 20, 2025 at 2:00 p.m.

Virtual Hearing via Zoom & In-person at Town Hall (30 Lewis St.) in the Council Chambers

What is being proposed?

The application proposes to create two (2) easements over the subject lands, both of which are for drainage purposes.

The first proposed drainage easement (A, shown below) has a frontage of approximately 3.0 metres (9.84 ft.) on Golf Course Road, a depth of approximately 56.09 metres (184.02 ft.), and an area of approximately 175.9 square metres (1,893.37 sq. ft.)

The second proposed drainage easement (B, shown below) has a width of approximately 6.59 metres (21.62 ft.), a depth of approximately 193.35 metres (193.35 ft.), and an area of approximately 1186 square metres (12,766 ft.)

OTHER APPLICATIONS: The property subject to this application for Consent (Easement) is also subject to an application for Draft Plan of Subdivision [Town File PS01/17].

The legal description of the subject lands is FLOS CON 7 AND 8 PT LOTS 25 AND 26 PT RD ALLOW AND RP 51R22127 PARTS 1 2 5 AND 54 TO 57 RP 51R36420 PARTS 1 AND 2.

The public hearing is your chance to make your views about the proposal known. Information from the public will help the Committee in their decision-making process, so make sure to have your say!

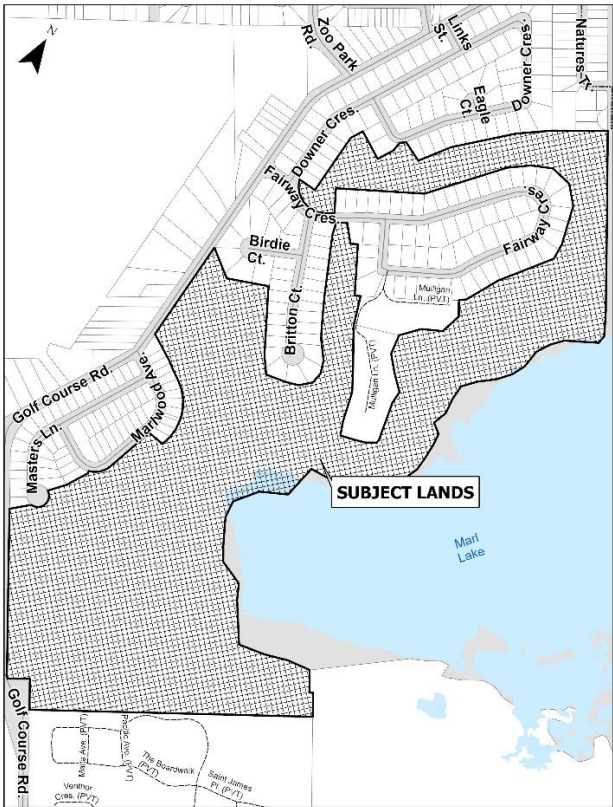

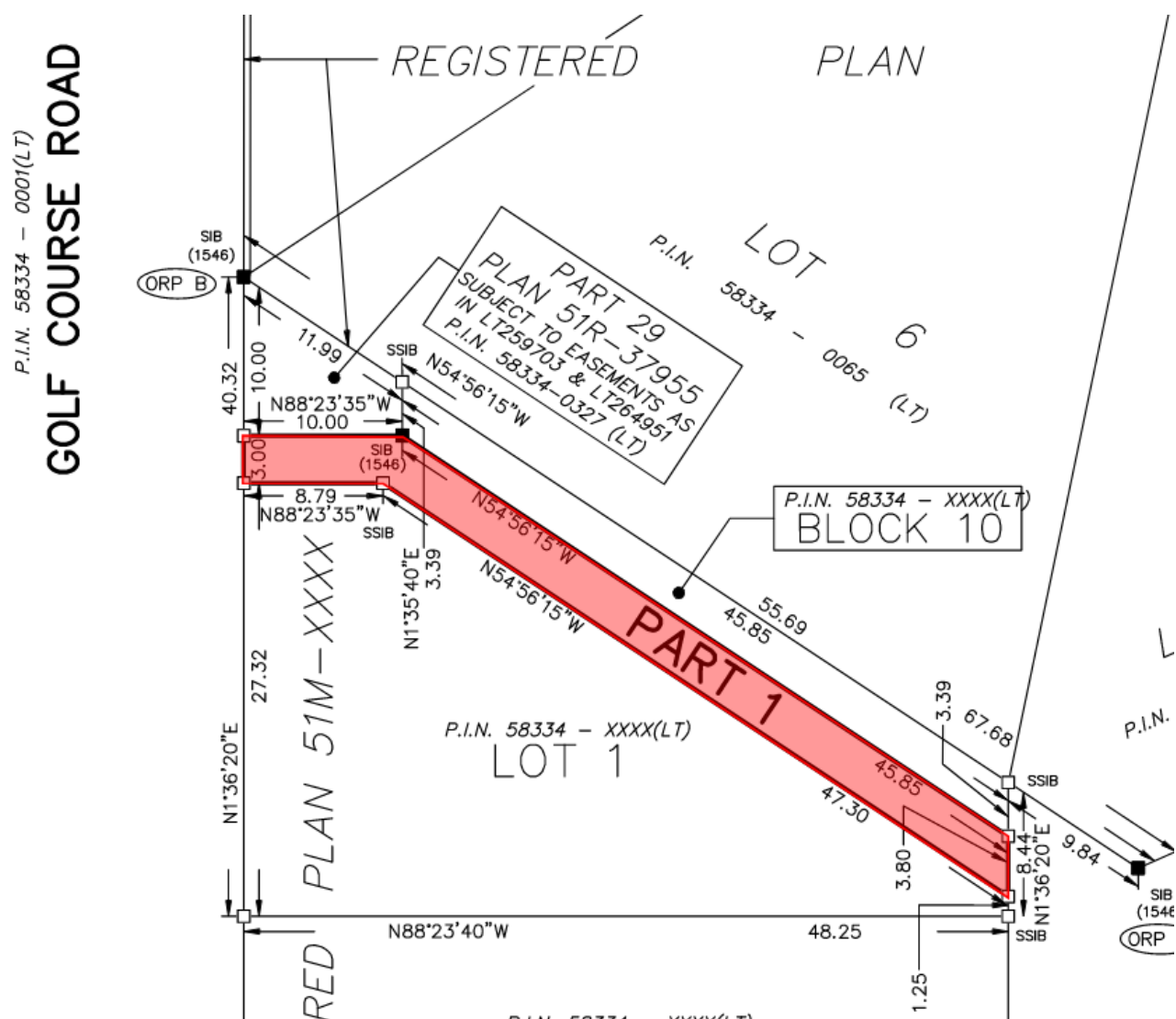
A note about information you may submit to the Town:

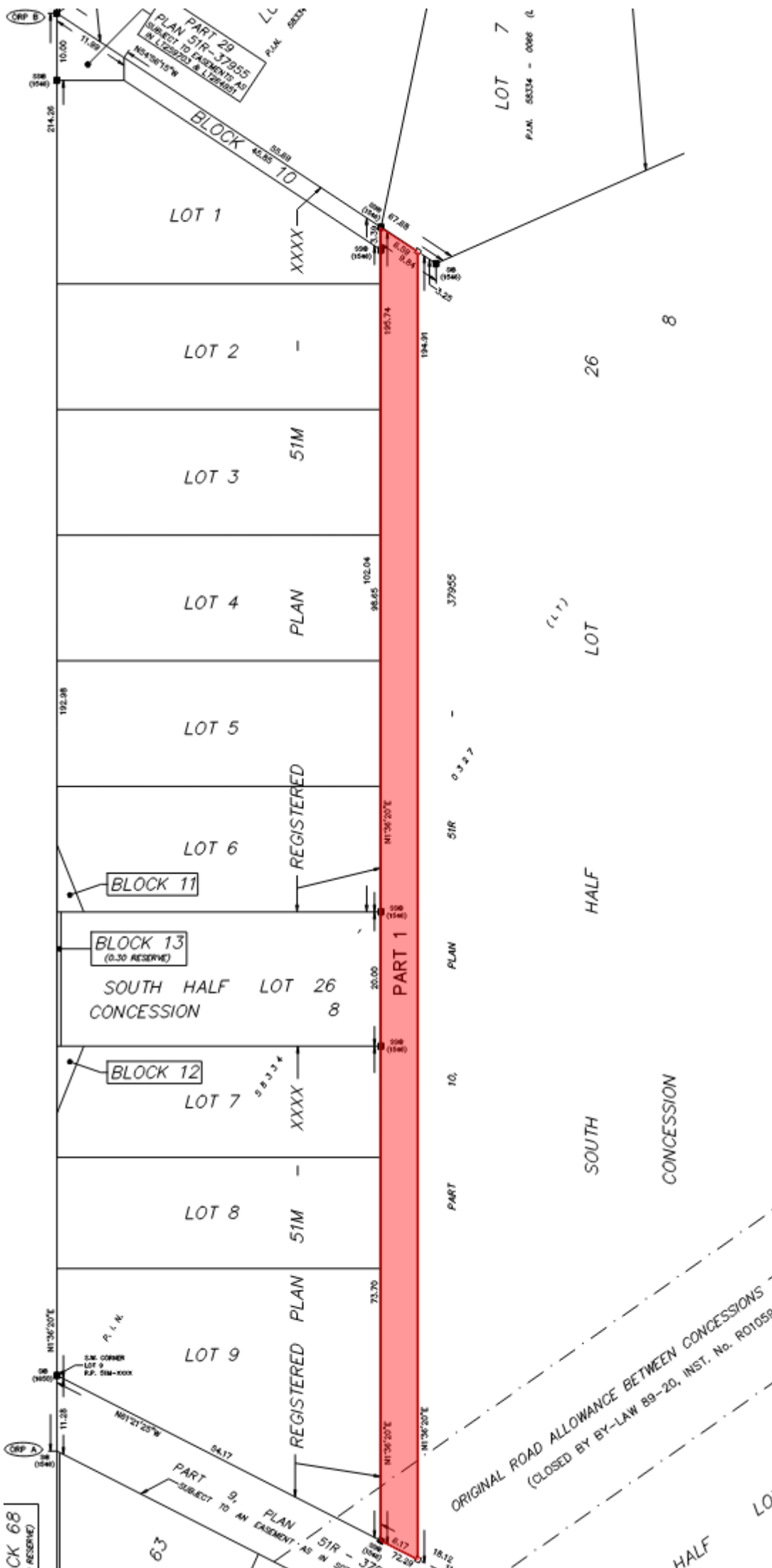
Applicant's Site Plan Sketch
