Application for Consent (Boundary Adjustment/Lot Addition) has been submitted by Zdenka Stracinski on behalf of Phil & Josie Aguanno.

What is being proposed?

The proposed boundary adjustment/lot addition will change the lot line configuration of the lands located at 931 River Road East and 933 River Road East.

The proposed boundary adjustment/lot addition proposes to sever 128.8 square metres (1386.39 sq. ft.) from the 931 River Road East lands, which is to be added to 933 River Road East lands.

The resultant enhanced/benefitting lot located at 933 River Road East will have an existing total lot frontage of approximately 15.5 metres (50.85 ft.) and an enhanced total lot area of approximately 736 square metres (7922.23 sq. ft.).



The retained lands located at 931 River Road East will have a total lot area of approximately 4661.2 square metres (50172 sq. ft.) after the transfer of the 128.8 square metres (1386.39 sq. ft.) portion of the 931 River Road East lands to the 933 River Road East lands.

OTHER APPLICATIONS: The lands known as 931 River Road East are currently the subject of a Consent Application, being Town File B1523.


